- Earlier this year as lodging tax began to be a discussion point with the City Council, I coordinated with the Chamber Director who willingly offered to reach out to engage lodging establishments in Fruita. This week I also reached out to most and will continue to do so letting them know of the upcoming public hearing on Jan. 7 and pending language of the possible ballot question.

## Engineering

- The contractor for the Highway 6 Sewer Extension project has bored the sewer casing pipe under the Independent Ranchman's Canal and has bored roughly 50 feet of the 270 feet under the highway/railroad.
- Brandon Estates Subdivision at the corner of Fremont & Ottley continued with utility construction this week.

#### **Parks and Recreation**

- The FCC was quite busy for the holidays as it hosted several events. The Arts and Crafts Fair had to be one of the busiest events ever. The gym and the meeting rooms were full of vendors and shoppers getting their last-minute presents ready for Christmas. And later that week Cookies and Claus was hosted in the gym.
- Representatives from the Fruita Trails Initiative will be presenting a grant request to Colorado Parks and Wildlife on Tuesday, January 14<sup>th</sup>. The grant request is to fund paleo and cultural survey work in the North Fruita Desert.
- A busy beaver has felled quite a few trees at Snooks Bottom this past week. Staff has hired a company to trap our furry resident and to help him find a new life somewhere else.

## **Public Works**

- A few employee highlights from 2019:
  - o 23% Turnover led to hiring of 6 new employees this year.
  - Provided training and had 3 employees obtain CDL driver's license.
  - o 4 employees passed exams for new, or higher-level, Wastewater licenses.
  - Implemented supervisor training program and hosted 4 training sessions focused on supervisory issues such as Ethics, FMLA, Legal Responsibilities, and Performance Management. Will be looking to expand on this in 2020.
- The 3 police vehicles budgeted for replacement in 2019 and ordered 9 months ago have still not been received due to a backlog of recalls, but we are hopeful to receive them shortly after the first of the year.

- Fleet disposed of \$25,331 worth of vehicles and equipment through government auctions this year.
- The wastewater plant collected \$4,250 this year from selling biosolids to commercial users and gave over 100 cubic yards away to residential customers.

### **MEMORANDUM**

To: Fruita Development and Real Estate Community

Re: Transportation Impact Fee Ordinance

Date: December 27, 2019

On December 17, 2019, the Fruita City Council adopted Ordinance 2019-21 (the "Ordinance"), which implemented a new transportation impact fee schedule, which schedule is attached hereto as Exhibit A. In addition, the Ordinance amended the Fruita Municipal Code to provide transportation impact fees shall be assessed at Final Plat rather than at Planning Clearance.

Pursuant to Section 2.13(G) of the Fruita Home Rule Charter, the Ordinance will take effect on January 16, 2020. However, as set forth below, the increase in transportation impact fees will be phased in over the next two years, and applicants who have submitted relevant development applications with the City prior to January 16, 2020 may not be subject to certain requirements under the Ordinance.

## Commercial Phasing

The increase in the transportation impact fee with respect to commercial, industrial and other uses shall be phased in over a period of two years pursuant to the following schedule:

Year (January 1)	Percentage of Fee to be Imposed	Base Fee	
January 1 2020	0%	\$1,589.00	
July 1, 2020	25%	\$2,882.50	
January 1, 2021	50%	\$4,176.00	
July 1, 2021	75%	\$5,469.50	
January 1, 2022	100%	\$6,763.00	

As noted, these fees will apply to all applications filed on and after January 16, 2020.

## Development Applications Under Review

All land development applications with applications currently under review or submitted prior to January 16, 2020 will have the option of paying the transportation impact fee at Planning Clearance or Final Plat. The amount of the transportation impact fee owed will depend on the base fee then in effect at the time the transportation impact fee is paid.

## Final Plat Applications Under Review

All Final Plat applicants with applications currently under review or submitted prior to January 16, 2020 may pay the transportation impact fee in effect at the time the application was submitted.

## Applications After January 16, 2020

All applicants who file a development application or Final Plat application with the City on or after January 16, 2020 shall pay the relevant transportation impact fee at Final Plat and pursuant to the schedule set forth in the Ordinance.

### Exhibit A

## **New Transportation Impact Fees**

## Residential:

The base rate for residential subdivisions with single family and duplex dwelling units for which no traffic impact analysis is performed shall be six thousand seven hundred sixty-three dollars (\$6,763.00) per dwelling unit.

For multi-family dwelling units in excess of two units, the base rate of six thousand seven hundred sixty-three dollars (\$6,763.00) shall be multiplied by a factor of 0.68 per unit for the fee per dwelling unit.

### Commercial, Industrial or Other Uses:

The transportation impact fee for commercial, industrial and other uses specified in the following table shall be a base rate of six thousand seven hundred sixty-three dollars (\$6,763) multiplied by the factor listed for that use.
