Fruita Community Center Rate Increase Begins January 15 (Continued)

Starting January 15, 2024, the Fruita Community Center will be implementing adjustments to the admission fees and membership rates. This is the first time since 2017 that the fee to the Fruita Community Center has been adjusted. Our number one goal is to serve the community to the highest standard, and this necessary change is essential to sustain our facility with rising operational costs and the effects of inflation over recent years. Daily rates will increase by \$1, and monthly/yearly passes will increase based on the \$1 daily admission increase. Waste Management Automated Trash Mailer (Continued)

Fruita residents should have received a mailer from Waste Management explaining the transition to the automated collection system. The mailer can be found online at fruita.org/trashcollection. During the weeks of January 8-26, 2024, a 96-gallon cart will be delivered to Fruita homes if the household doesn't already have one. If a household participates in recycling services, Waste Management will drop off a new 96-gallon recycling container on the household's normal recycling schedule. Parks and Recreation

- **2023 FCC Visitation.** In 2023, the Fruita Community Center saw 187,339 visits, which is a 7% increase from 2022. This number does not include visitation to the Senior Center or meeting rooms.
