

RESOLUTION 2021-40**A RESOLUTION SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND
AND ADOPTING A BUDGET FOR THE CITY OF FRUITA, COLORADO,
FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY, 2022,
AND ENDING ON THE LAST DAY OF DECEMBER, 2022**

WHEREAS, the City Manager has directed the preparation of the 2022 Annual Budget for submission to the Fruita City Council for their consideration;

WHEREAS, a proposed budget was submitted to this governing body on September 28, 2021, for its consideration, and;

WHEREAS, upon due and proper notice, published in accordance with the law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on November 16, 2021 and continued to December 7, 2021, and interested taxpayers were given the opportunity to file or register any objections to said proposed budget, and;

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.
