LIABILITY WAIVER

I, _____, request the opportunity of accompanying an on-duty Fruita Police Officer, in the capacity of a civilian ride-along, during the performance of their general patrol duties. I understand this will include my being in and about city owned vehicles and property as well as public roadways, thoroughfares, highways and/or interstates. I understand that I may be witness to information that must be kept confidential and I agree to do so. I agree to dress appropriately and present myself in an appropriate manner. I understand this is a privilege which may be revoked at any time for any reason.

I understand there are inherent risks and hazards in law enforcement many of which may be beyond the capacity of the Fruita Police Department to control. By participating in the Fruita Police Department Ride-Along program I do release and forever discharge the City of Fruita and the Fruita Police Department, it's representatives, officers, agents, and employees of, from all actions, causes of action, in law or equity, in any jurisdiction, including but not limited to – Federal, State, and City, for personal injuries, damages or losses of any nature whatsoever, which may result from, or occur at any time, while I am in or about city owned vehicles or property, as well as public ways, thoroughfares owned, leased or in possession of any governmental agency, and do further agree to hold the city harmless of any claims, demands, or actions which may arise in any way as a result of my presence in or about said vehicles, pursuant to the privilege hereby granted.

RULES AND EXPECTATIONS

- Participants are expected to be on time for their scheduled ride-along.
- Participants shall not use any profane or abusive language or display any offensive or inappropriate behavior during the ride-along that may embarrass the officer, the Fruita Police Department or the City of Fruita.
- Participants must stay in the patrol vehicle unless otherwise indicated by the patrol officer they are assigned to accompany.
- Participants WILL NOT operate or use any departmental equipment or vehicles, except in the case of an emergency or when the officer directs you to do so.
- Participants WILL NOT wear or keep on their person any weapons (firearms, knives or otherwise) unless approved in advance.
- Participants WILL NOT carry or operate a recording device or camera during their participation unless approval is obtained in advance.
- The length of Ride-Alongs can vary due to a variety of circumstances and usually range from two-hours to eight hours. It should be understood, law enforcement is a dynamic occupation and subject to circumstances outside of the departments control. This may extend or shorten a participant's Ride Along experience.
