QUESTIONS

Question 1: Will an equivalent Davis color be allowed as an alternate?

Answer: Davis color-Cliffside Brown 6804 can be substituted for the specified Schofield

5234 Summer Beige.

Question 2: Can you verify the tree quantities in the Bid Form?

Answer: Line 20, Sheet G4, should be updated to zero (0) transplanted trees. Line 18 is correct with 14 trees as is sheet LS101 with 14 trees. The revised Bid Form reflecting these bid quantities is attached.

Question 3: Does the City want to include the use of a root guard for the Skyline Honey Locust

trees?

Answer: No.

Question 4: What does the City want to do with the existing boulders in the planters that will be reconstructed?

Answer: Existing boulders shall be removed and relocated to the planter bed along Peach Street south of Aspen Avenue adjacent to City-owned parking lot.

Question 5: The current plant schedule indicates that perennials are to be supplied as 5 gal. stock. Is this correct?

Answer: The plant schedule has been changed to 1-gallon size for all perennials in the Plant Schedule on Sheet LS101 except for the Bouteloua gracilis / Blue Grama Grass that will remain as 5 gallon size.

Question 6: Which trees are proposed for re-location?

Answer: The bid schedule has been revised to reflect that there will not be any trees transplanted.

SPECIAL PROVISIONS

The following items are added to the Special Provisions item descriptions:

Item 15A Removal of Stone Boulders and Reset at Alternate Location: Stone boulders in existing planters shall be removed and relocated to the planter bed along Peach Street south of Aspen Avenue adjacent to City-owned parking lot. Location and placement within the bed shall be as directed by the City. This pay item includes furnishing all equipment, materials and labor necessary to remove, protect, transport and place boulders in new location as directed by the City Project Manager. Payment of this Lump Sum item shall be made in increments upon completion of construction.

Item 37A 30"x18" RCP Special Wye: This pay item shall be all equipment, materials, and labor necessary to fabricate a reinforced concrete wye to the sizes dimensions as called out on the plans and install wye in place including bedding, backfill to subgrade elevation. Wye shall meet the requirements of ASTM C76 with a minimum Class III. Payment shall be made on the completed Unit Price quoted for each wye.

PLANS

The following revisions shall be incorporated into the plans (construction drawings):

Irrigation drawings are **not** included in the plans and effort to reconnect existing irrigation lines and installing new irrigation lines is not to be included in the bid. Providing irrigation to the new plants will either be added to the contract at a later date as part of a Change Order or installed by others and will be determined by the City.

Sheet LS101 shall be revised to replace the Perennials Plant Schedule with the following:

- b. Irrigation Currently the existing planters are served by a Ute Water service. We are investigating the possibility of converting the planters to utilize the Civic Center Irrigation system. Addition information will be provided by addendum.

V. TRAFFIC CONTROL

A traffic control plan will need to be prepared by the contractor and submitted to City of Fruita Public Works for review and approval as part of City of Fruita Right of Way Permit.

Both pedestrian and vehicular traffic are to be included in the traffic control plan's bid item for Traffic Control.

- a. City willing to allow full closure of 1 intersection at a time.
- b. Access for individual properties must remain open. We can work with some businesses on their hours of operation so that we are prepping/pouring concrete on a day that works to minimize disruption.
- c. Need to have additional signage indicating businesses are open within the work zone.
- d. There will be opportunities for closures of some of the side street areas for the use of staging areas. The idea is to keep Aspen Ave. open for as much as possible.

VI. CONSTRUCTION ITEMS OF NOTE

- a. Integral Colored Concrete with 2'x2' joint pattern
- b. Decorative Concrete Crosswalk
- c. Seating Walls with Sandstone face
- d. Electrical Service Upgrades 4-50 Amp and 2 duplex 40-amp service. May open cut those based on what we get back on irrigation
- e. Landscape Beds
- f. Benches and/or any fencing for outdoor seating not included in the contract and will be installed by the City/or adjacent business
- g. Special concrete Wye 30"x18"

h. Drainage Inlets on Bid Schedule calling out Type-R CDOT Inlets will be revised to City of Fruita Single and Double inlets (or equivalent City of Grand Junction) with vertical curb face.
