REQUEST FOR BIDS –  
2024 Street Striping Project**

**Street Striping Project 2024**

The City of Fruita is requesting bids for the 2024 Street Striping Project, which will consist of striping approximately 360,000 feet of 4” yellow/white/turn line striping (solid and dashed), as needed throughout the City of Fruita. The Contractor will provide cost per foot in length four inches wide. All lines will be covered in glass beads.

The downtown area may be painted at night or early in the morning. If there is a cost difference, please note on Bid Sheet “after hours painting” and additional cost per foot.

**PRODUCT SPECIFICATIONS**

The paint shall be waterborne, and all paints shall meet Federal Specifications TT-P 1952D type I and type II. All paint shall be applied according to the manufacturer’s recommendations. The Contractor shall submit manufacturer’s testing results and application instructions to the Public Works Department 30 days prior to job start date. No paint substitutions will be allowed without prior approval. Glass bead size and application rate will be specified by the paint manufacturer and provided to the City of Fruita along with the paint specifications.

**SCOPE OF WORK**

Contract painting consists of mostly double yellow center stripes with some dashes. White lines are bike lanes and fog lines. The City of Fruita will paint hash marks on new streets or recently chip sealed streets to aid in striping. The City of Fruita will provide a leader truck to assist the painting crew, if desired, at no cost to the Contractor. The Contractor shall provide all traffic control for the project. Excessive wheel tracks through wet paint caused by a lack of cones shall require blackout painting by the Contractor at no additional charge. Determination of excessive tracks will be at the discretion of the City of Fruita.

**ESTIMATED DATES FOR PAINTING**

Late Summer/Fall 2024, depending on completion of chip seal and overlays this year.  
Date of Final Completion shall be by October 17, 2024.

**CAUSES FOR TERMINATION**

City of Fruita reserves the right to cancel the contract at any time paying only the agreed upon price per foot for painted lines at the time of termination and agreed upon mobilization costs.

### **LAYDOWN YARD**

The Contractor may store supplies and trucks at the Fruita Public Works yard located at 900 Kiefer Avenue in Fruita, CO.

### **MATERIAL TESTING**

No testing will be required; although Contractor shall show quantity of gallons of each type of paint used and pounds of glass beads.

The City of Fruita shall require painting a known distance to prove footage paint counter before job starts. Any unreasonable discrepancy shall be resolved before painting continues.

Footage shall be read and recorded each day by an appointed Fruita Public Works crew member. Any footage discrepancy that would seem unreasonable shall be proven by engineering-grade GPS.

### **BID BOND**

Bid Bond will not be required for this project. Public Works will provide a Right-of -Way permit, upon submission of an approved traffic control plan. Contractor shall provide performance, payment and warranty bonds as described in Section 15.3.7 of the contract. The cost shall not exceed 2.5 percent of the amount set forth in section 3.4 of the contract to the City of Fruita.

### **TRAFFIC CONTROL**

The Contractor shall provide all traffic control for the project. The Contractor will place cones at the edge of wet lines and as often as needed to inhibit motorists from crossing wet painted lines. Costs associated with setting out cones and picking them up shall be included in the per foot price of painting.

### **QUALITY OF WORKMANSHIP**

Failure to follow existing lines, excessive weaving or crooked lines may result in contract revocation. The City of Fruita reserves the right to cancel the contract at any time for poor quality workmanship.

### **MOBILIZATION**

Mobilization costs shall be indicated on the bid form. This cost is to reflect the total cost per painting occurrence.

### **INSURANCE REQUIREMENTS**

Each bid shall include a copy of insurance certificates or other evidence of the following minimum insurance requirements:

1. Proof of Workers' Compensation Insurance pursuant to the State of Colorado.
2. Comprehensive General Liability Insurance with the City named as additional insured in the amount of \$500,000/occurrence, and \$1,000,000/aggregate.

3. Comprehensive Automobile Liability Insurance with the City named as additional insured in the amount of \$500,000/occurrence, and \$500,000/aggregate.

### **BID SUBMITTAL**

All Bids must be received at the main administrative counter in the Fruita Civic Center, 325 E. Aspen Avenue, Fruita, CO 81521 no later than 1:00 p.m. on Friday, May 24, 2024. Bids will be opened and read publicly at 1:00 p.m. on Friday May 24, 2024 in the Council Chambers located on the 2<sup>nd</sup> floor of the Civic Center. It is the sole responsibility of the bidder to see that the quotation is received before the submission deadline. The bidder shall bear all risks associated with delays in the U.S. mail or delivery service. To mail a bid, please address to: City of Fruita Public Works Department, 325 E. Aspen Avenue, Fruita, CO 81521. Please make sure to mark on the outside envelope "City of Fruita 2024 Street Striping Proposal". Late quotations will not be considered.

The City of Fruita is exempt from all local, state, and federal taxes.

The successful bidder must have a current City of Fruita Business License.

The City of Fruita reserves the right to reject any and all bids, to waive any informalities and minor irregularities in bids, and to accept the bid deemed, in the opinion of the City, to be in the best interest of the City of Fruita.
